Issue/Request:

AN ORDINANCE APPROVING A COOPERATIVE AGREEMENT BY AND BETWEEN THE CITY OF LEE'S SUMMIT, MISSOURI AND SHOW ME PACE, A MISSOURI CLEAN ENERGY DEVELOPMENT BOARD, AND AUTHORIZING THE EXECUTION OF DOCUMENTS RELATED TO THE SHOW ME PACE PROGRAM FOR PARTICIPATION BY THE CITY OF LEE'S SUMMIT, MISSOURI.

Key Issues:

- On June 15, 2015, Show Me PACE, a clean energy development board was established within the State of Missouri with the intention that all Missouri municipalities would be eligible to join and participate by approving an appropriate ordinance or resolution.
- The City Council of the City of Lee's Summit approved Ordinance No. 7767 on December 10, 2015 authorizing the City of Lee's Summit to participate in the Missouri Clean Energy District as authorized by the Property Assessment Clean Energy Act as enacted by the 95<sup>th</sup> General Assembly of the State of Missouri.
- On January 27, 2016, the City of Lee's Summit approved Ordinance No. 7800, authorizing the City of Lee's Summit to join and participate in Show Me PACE.
- Show Me PACE has presented to the City a Cooperative Agreement which outlines the terms and conditions of participation and has requested its approval and execution.

Authorization is needed for the Mayor to execute the Cooperative Agreement as well as any other documents necessary to effectuate the City's participation in the program.
