Public Hearing: Application #PL2020-279 - Vacation of Right of Way - An approximately 700' segment of NW Black Twig Lane located north of NW Lowenstein Drive; Streets of West Pryor, LLC, applicant.

Issue/Request:

The subject vacation of right-of-way application is associated with the rezoning and preliminary development plan (Appl. #PL2020-274) application for Streets of West Pryor, Lots 7 and Tract C, that is also on this agenda. Whereas a previously approved preliminary development plan called for the extension of NW Black Twig Ln north of NW Lowenstein Dr as a public street, a new proposed preliminary development plan instead calls for access to the property to be provided via a private drive/street of the same general configuration as was previously approved.
