	Rehabilitation, strengthen and extension work of Runway $18/36$ will be completed in the fall of 2017 .			
	This modification includes Design Engineering Services for Taxiway Paving of Taxiway Alpha and other incidental work.			
	The City of Lee's Summit anticipates receipt of grants from the Missouri Highways and transportation Commission \$338,936.40 to pay for these services.			
	Local matching funds of \$18,829.80 5% of the project cost are required and are			
	available from the Airport Capital Funds are available for the local match. Staff received a letter from MoDOT dated October 19, 2016 notifying the City of a
