Issue/Request:

Key Issues:

- The current cooperative contract to purchase medical supplies and equipment is expiring
- The contract is used by the Fire department to acquire medical supplies and small equipment for use in ambulances and fire trucks
- The City of Lee’s Summit is a member of the Mid-America Regional Council Emergency Response (MARCER) team that reviews and makes recommendations to MARC

I move to recommend to City Council for approval an Ordinance approving the use of a Cooperative Contract between Mid-America Regional Council and Life-Assist, Inc., to purchase medical supplies and equipment as needed and authorizing the City Manager to execute the same for the City.
