PUBLIC HEARING - Appl. #PL2016-218 - SPECIAL USE PERMIT for automotive sales - Kansas City Motors, 704 and 708 SE Oldham Court; Kansas City Motors, LLC, applicant.

Issue/Request:

This application is for a special use permit to allow for the operation of automotive sales at 704 and 708 SE Oldham Court. The applicant requests a time period of twenty (20) years. Staff is supportive of the requested time period since the associated building is new construction.

Proposed City Council Motion:

I move to direct staff to present an ordinance approving Appl. #PL2016-218 - SPECIAL USE PERMIT for automotive sales - Kansas City Motors, 704 and 708 SE Oldham Court; Kansas City Motors, LLC, applicant.

Recommendation: Staff recommends APPROVAL of the special use permit, subject to the following:
