Key Issues:

The Downtown Lee's Summit Community Improvement District (hereinafter "the District") was established by the City Council through the adoption of Ordinance No. 7478 on June 19, 2014

The District is designed to provide funding for public services and improvements that are needed to sustain Downtown and its' incorporation into the community and region

The District and City desire to enter into an agreement to provide for the scope of work and compensation to be paid for such work.

Background:

As outlined in the Five Year District Management Plan of the Downtown Lee's Summit Community Improvement District dated March 4, 2014, the District provides basic public services and improvements that in general preserve, promote, and enhance the District for its' various patrons, including initiatives entitled "Clean & Green," "Community Development," "Capital Improvements," and "Administrative Services.

Impact/Analysis:

One full time equivalent Facility Maintenance Worker is budgeted in the current fiscal budget.

<u>Timeline:</u> Start: Novermer 1, 2017 Finish: TBD

Other Information/Unique Characteristics:

The new FTE will perform the part time services described in Exhibit A, as well as perform part time work in the Central Building Services division.
