## Background:

The public hearing for Application #PL2018-234 - Preliminary Development Plan - DTLS Apartments, 114 SE Douglas Street; Cityscape Properties, LLC, applicant was held on March 19, 2019 and the public hearing closed. Subsequent to the public hearing, A motion was made and seconded that Bill No. 19-50 be advanced to second reading to coincide with the reading of the [ordinance for the] financial incentive package. A substitute motion was then made and seconded that consideration of Bill No. 19-50 be postponed to coincide with the report from the TIF Commission regarding the Preliminary Development Plan at 114 SE Douglas Street. The substitute motion carried by a vote of 6 - 3.

\*\*\*A condition of approval has been added to the ordinance requiring the developer to execute a mutually satisfactory development agreement with the City, which addresses, at a minimum, sanitary sewer improvements.\*\*\*
