\$225,000 is being recommended to be set aside for Small Business Assistance, to be administered by Velocity Lee's Summit, Inc.

With the support of the Lee's Summit Chamber of Commerce, Lee's Summit Economic Development Council, Downtown Lee's Summit Main Street and individual volunteers from the Lee's Summit community, Velocity is proposing to provide grants up to \$5,000 to eligible businesses for the purpose of offsetting losses and expenses incurred as a result of the public health emergency with respect to COVID-19.
