### Issue/Request:

An Ordinance authorizing the execution of a Missouri Highways and Transportation Commission Amendment to State Block Grant Agreement, Amendment #1 for Project No. 13-109A-1 by and between the City of Lee's Summit, Missouri, and the Missouri Highways and Transportation Commission, granting federal funds in the amount of \$16,216.00 and for extending the grant expiration date to December 30, 2020 for assisting with runway 11-29 pregrading at the Lee's Summit Municipal Airport.

### Key Issues:

- The Lee's Summit Municipal Airport received a grant for 861,956.00
- The project is in the process of being closed out
- This amendment provides for granting additional funds in the amount of \$16,216.00 and extends the grant expiration date from December 30, 2014 to December 30, 2020.
- Local matching funds in the amount of \$883.00 are available from the Transportation Sales Tax.
- In order to close the project and received all available grant funds, this amendment must be approved

by the City Council.

Proposed Council Motion:

FIRST MOTION: I move for second reading of an Ordinance authorizing the execution of a Missouri Highways and Transportation Commission Amendment to State Block Grant Agreement, Amendment #1 for Project No. 13-109A-1 by and between the City of Lee's Summit, Missouri, and the Missouri Highways and Transportation Commission, granting federal funds in the amount of \$16,216.00 and for extending the grant expiration date to December 30, 2020 for assisting with runway 11-29 pregrading at the Lee's Summit Municipal Airport.

SECOND MOTION: I move for adoption of an Ordinance authorizing the execution of a Missouri Highways and Transportation Commission Amendment to State Block Grant Agreement, Amendment #1 for Project No. 13-109A-1 by and between the City of Lee's Summit, Missouri, and the Missouri Highways and Transportation Commission, granting federal funds in the amount of \$16,216.00 and for extending the grant expiration date to December 30, 2020 for assisting with runway 11-29 pregrading at the Lee's Summit Municipal Airport.

Background:

The Lee's Summit Municipal Airport received a grant for \$861,956.00 for the Runway 11-29 Pregrading. During the process of closing out the project, it was determined additional grant funding would be required. This amendment provides for granting additional funds in the amount of \$16,216.00 and extends the grant expiration date from December 30, 2014 to December 30, 2020. In order to close the project and received all available grant funds, this amendment must be approved by the City Council.
