The Lee's Summit Municipal Airport received a grant for \$31,457.00 for the Runway 11-29 Pregrading. During the process of closing out the project, it was determined additional grant funding would be required. This amendment provides for granting additional funds in the amount of \$883.00 and extends the grant expiration date from December 30, 2014 to December 30, 2020. In order to close the project and received all available grant funds, this amendment must be approved by the City Council.
