Public Hearing: Application #PL2020-240 - Rezoning from AG to RLL - Pine Tree Farm Estates, 1050 NE Todd George Rd; Keith Foster, applicant.

### Issue/Request:

The applicant proposes rezoning a 7.8-acre parcel from AG (Agricultural) to RLL (Residential Large Lot) for a proposed 6-lot single-family residential subdivision. The requested RLL zoning requires a minimum 0.5-acre lot size.
