### Background:

At the November 11, 2020 Community & Economic Development Committee (CEDC) meetings staff provided a presentation and framework to begin a process of evaluation and community dialogue regarding a coordinated effort to respond to homeless related concerns within the community, and to begin to connect available resources across a multi-faceted and multi-discipline approach.

At the December 9, 2020 CEDC meeting additional discussion was held regarding a proposed approach and composition of a Community Coalition on Homelessness and the CEDC agreed that CEDC Chairperson Forte and Vice Chairperson DeMoro would serve on the Coalition from an elected official perspective.

### Other Information/Unique Characteristics:

The CEDC has expressed interest and support toward creating a community coalition of stakeholders to develop a longrange plan to respond to homelessness within the community. Below are key aspects that the coalition could focus efforts around:
