### Issue/Request:

An Ordinance approving the 2021 Jackson County Board of Election Commissioners Poll Contract for the Harris Park Community Center and authorizing the Mayor to execute the same by and on behalf of the City.

### Key Issues:

Each year, the Jackson County Board of Election Commissioners (JCBE) uses certain City and Lee's Summit Parks and Recreation owned facilities as polling places. For 2020, JCBE has requested the use of Gamber Community Center, Longview Community Center and the Lovell Community Center for elections to be held in March, April, August and November 2021. Those contracts were previously approved. After that ordinance was adopted the Jackson County Election Board requested the use of the Harris Park Community Center.

Because JCBE is a political subdivision, RSMo. Section 70.220-70.230 is applicable, and requires the approval of the Agreements by the governing body of Lee's Summit, Missouri.

### Proposed Council Motion:
