Issue/Request:

An Ordinance approving the use of a Cooperative Contract between the Jasper County Sheriff's Office and Turn-Key Mobile, Inc., to purchase computer and network technology as needed and authorizing the City Manager to execute the same for the City.

Key Issues:

-The City has a need to purchase computers and network technology equipment for use in police vehicles -The current cooperative contract to purchase computers and network technology from Turn-Key Mobile has expired

-The primary use of the contract is to purchase Panasonic Toughbook laptops used by police and fire staff that work primarily out of vehicles

-The Jasper County Sheriff's Office awarded the bid for the necessary items to Turn-Key Mobile and the contract allows other public agencies to Piggyback
