### Key Issues:

Each year, the Jackson County Board of Election Commissioners (JCBE) uses certain City and Lee's Summit Parks and Recreation owned facilities as polling places. For 2022, JCBE has requested the use of the Lovell Community Center, Harris Park Community Center, Longview Community Center and the Gamber Center for elections to be held in February, April, August and November 2022 and February 2023.

Because JCBE is a political subdivision, Sections 70.220 and 70.230, RSMo. apply, and require the City Council to approve the agreements before the Mayor can sign them.
