Issue/Request:

The City has a need for repair and maintenance of electrical systems on occasion and installation of addition electrical service as the City's facilities needs grow.

For several years the City has piggybacked on contracts available from other agencies. The City's needs have grown so the City issued its own solicitation for electrical services.

Background:

The City currently piggybacks on the City of Independence contract for electrical services. The contract is close to expiration. The City issued Bid No. 2022-029, for electrical services. Over 40 vendors were notified and invited to submit bids. Three (3) bidders responded with responsive bids. The bids were evaluated and Greenwood Energy Solutions, LLC was identified as the lowest responsive bidder.
