Issue/Request:

<u>Key Issues:</u>

- City departments have the need for new installation or repair of fences around City properties.
- Pursuant to the City's procurement policy, the City has used the Jackson County contract for fencing with Guier Fence for many years.
- The current cooperative contract with Guier Fence Company expired at the end of March, and Jackson County issued a bid and awarded the new contract to Guier Fence.
- The City needs approval from the City Council to use the Cooperative Contract because the City may spend more than \$50,000 annually under the contract.
