Public Hearing: Application #PL2023-068- Unified Development Ordinance (UDO) Amendment for an Ordinance amending Chapter 33, Articles 7 Subdivisions, of the Lee's Summit Code of Ordinances, to allow for requirement of public infrastructure with the administrative approval of minor plats; City of Lee's Summit, applicant.

Background:

The proposed Unified Development Ordinance (UDO) amendment to the subdivision ordinance is to require public infrastructure for minor plats that create *new* lots. The amendment was first discussed at the Community and Economic Development Committee (CEDC) on April 12, 2023. The committee unanimously voted to recommend the approval of the ordinance to the City Council. After CEDC the amendment is following the standard process of a public hearings at Planning Commission and City Council.
