An Ordinance authorizing the execution of a Missouri Highways and Transportation Commission Second Supplemental Agreement to Airport Aid Agreement for Project No. 166-109A by and between the City of Lee's Summit, Missouri, and the Missouri Highways and Transportation Commission, extending the grant expiration date to December 31, 2021 for assisting with relocation and extension of taxiway A at the Lee's Summit Municipal Airport. Issue/Request:

An Ordinance authorizing the execution of a Missouri Highways and Transportation Commission Second Supplemental Agreement to Airport Aid Agreement for Project No. 166-109A by and between the City of Lee's Summit, Missouri, and the Missouri Highways and Transportation Commission, extending the grant expiration date to December 31, 2021 for assisting with relocation and extension of taxiway A at the Lee's Summit Municipal Airport.

Key Issues:

- The Lee's Summit Municipal Airport received a grant for \$346,333.00
- The project is in the process of being closed out
- This amendment extends the grant expiration date from December 31, 2019 to December 31, 2021.
- In order to close the project and received all available grant funds, this amendment must be approved by the City Council.

Proposed Council Motion:

FIRST MOTION: I move for second reading of an Ordinance authorizing the execution of a Missouri Highways and Transportation Commission Second Supplemental Agreement to Airport Aid Agreement for Project No. 166-109A by and between the City of Lee's Summit, Missouri, and the Missouri Highways and Transportation Commission, extending the grant expiration date to December 31, 2021 for assisting with relocation and extension of taxiway A at the Lee's Summit Municipal Airport.

During the process of closing out the project, it was determined additional time would be required to submit the final reimbursement request. In order to close the project and received all available grant funds, this amendment must be approved by the City Council.
